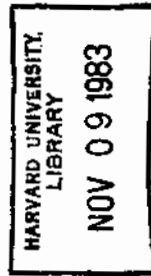

Acknowledgements

This study is the product of two related efforts: a search for sources and historical data on Timbuktu, and secondly an attempt to synthesize the data within a meaningful framework of analysis. In both respects I have received the assistance of many scholars and librarians, as well as the cooperation of traditionists at Timbuktu. I mention below only those whose assistance was exceptionally valuable.

For data which have directly contributed to the making of this study, I wish to express my deep gratitude to John Hunwick. During my brief visit to Cairo he kindly opened to me his personal library, including the notes taken by him over the years from manuscript libraries dealing with West Africa. Since it was not always possible to acknowledge his contributions and suggestions in their proper place in the text, it is necessary to emphasize them here. Similarly, I would like to thank Professor Jean Devisse of the University of Paris for lending me personal copies of sources which otherwise may not have been accessible.

The search for the multitude of fragmentary and dispersed sources on Timbuktu is a difficult one. I am grateful for a Fulbright-Hays grant and a Social Science Research Council fellowship which made my overseas documentary and field research possible. Hans Panofsky and Dan Britz of the Africana Library at Northwestern University kindly exerted their efforts in procuring for me in advance some of the manuscript sources from abroad. In Paris, the staff of the Institut de France was most helpful, while in Rabat I found cooperation both at the National and Royal libraries. Additionally, I should mention the special assistance of Muṣṭafa N'jai of the Institut Fondamental d'Afrique Noire at Dakar.

In Mali my research was greatly facilitated by the assistance and companionship of Alamy Malik Yettara of the Patrimoine Historique et Scientifique. I am also most grateful to the staff of the Centre Ahmad Bâba of Timbuktu, especially to the director, Maḥmūd Zoubeir, whose ideas contributed substantively to this study, and the assistant director, Nuri Muḥammad al-Amin, who exerted a special effort to facilitate my research. The elders and alfas of Timbuktu were most forthcoming in their

information and assistance. I am deeply grateful to Alfa Humal, *Imâm* of Jingerebir, Mulay Ahmad Babir, present-day chronicler of Timbuktu, Alfa Salum, *Imâm* of Sankore, Alfa Ahmad Banio, *Imâm* of Sidi Yahya, al-Shaikh 'Issa Wuld Muhammad Mawlūd, Alfa of the Keltina al-Hāji, al-'Alim Zubeir, held by some to be the honorary *Qādi* of Timbuktu, and the Songhai elder Ahmadu Badiji. Equal gratitude is extended also to the young Alfa Yahya Ibrāhīm, educator and sometime historian in Timbuktu.

I should reserve my deepest gratitude to Ivor Wilks. His suggestions have helped shape many of the directions taken by this study. His advice during the past few years has combined sensitive criticism with warm encouragement in a singular manner. From the planning of the research to its completion, his help has been most consequential. It is therefore important that I should especially associate his assistance with any contribution that the study may make.

Since completing the original draft of this study, I have had an opportunity to revise it in certain important ways, including the addition of a concluding section, besides a much longer introduction (Chapter 1). In this respect I would like to thank Dr Michael Cook and Dr Martin Hinds who read the manuscript on behalf of Cambridge University Press and who offered a significant and valuable set of suggestions. Additionally, I would like to express my appreciation to Wellesley College whose support greatly facilitated the revision of the study.

Finally, I should credit the special effort and exertions of my wife Julianna. At various stages of this study, and especially during the overseas research, her assistance and encouragement was most important. I owe to her many substantive suggestions as well as numerous editorial corrections and improvements.
